The Delaware River Waterfront Corporation is building the Race Street Pier, a new, one acre park on the Central Delaware River Waterfront. We already have a great park planned and, with your help, we can make it even better!

Race Street Pier has the amazing opportunity to incorporate nearly full-grown, 20-22 feet tall trees.

These trees were grown as back-up trees for the memorial park at the World Trade Center site in NYC but are not being used, therefore we have been given the chance to purchase them for Race Street Pier.

Unlike the standard 14-16 feet tall (4" caliper) tree that is budgeted for the park but will take years to grow, these special trees are larger and stronger. Rather than waiting a decade for park trees to mature, these full-grown trees will have a dramatic and immediate effect on the aesthetics and shade of the new park.

DRWC had originally budgeted \$2,500 per tree. The large, spectacular trees will cost \$5,000 each, so we are looking for 37 sponsors to donate \$2,500 each to match the funds we have already secured.

The trees will be planted in early spring 2011 in preparation for Race Street Pier Park's grand opening later that spring.

Sponsors may be either individuals or corporations. All sponsors will be acknowledged or have the chance to dedicate their tree in the paving at the base of the tree (unless a sponsor has chosen to remain anonymous).
