

PETITION OF HSP GAMING, L.P. FOR APPROVAL OF PROJECT FINANCING

NOW COMES, HSP Gaming, L.P. ("HSP"), a Category 2 Slot Machine Licensee, and hereby petitions the Pennsylvania Gaming Control Board (the "Board") pursuant to 58 Pa. Code §493a.4, 4 Pa. C.S. §§1202 and HSP's Statement of Conditions at ¶31 for approval of financing for the construction and development of its Interim Phase Casino. In support of this Petition, HSP avers as follows:

BACKGROUND

- On January 11, 2008, HSP was issued a Category 2 Slot Machine License
 (License No. F-1311) by the Board.
- 2. As stated at the May 6, 2009 Board meeting, HSP intends to open with an Interim Facility which will include, among other things, an approximately 40,000 square foot gaming floor containing 1,700 slot machines, three food and beverage outlets and approximately 1,465 parking spaces.

3. On May 6, 2009, the Board approved HSP's modification development plan to its development plan in accordance with the representations, drawings and diagrams presented to the Board in support of its Petition.

4. HSP proposes to enter a permanent financing transaction ("Financing Transaction") pursuant to the terms and conditions contained in the Credit Agreement and related ancillary documents.

5. The proceeds from the Financing Transaction will be utilized to construct, develop and open the Interim Facility.

6. Under the Financing Documents, a condition precedent to the closing is Board approval of the Financing Transaction.

WHEREFORE, for the reasons set forth herein, HSP respectfully requests that the Board order as follows:

a. The Financing Transaction complies with the provisions of the Gaming Act and Board Regulations; and

b. The Financing Transaction is approved.
