Dear Governor Rendell, Representative Evans, and Senator Fumo:

In recent days, there has once again been a great deal of conversation and debate about whether SugarHouse Casino should be built in Fishtown. Unfortunately, no one has asked us, residents of the Fishtown community and members of Fishtown Action (FACT), the largest membership organization in the Fishtown community with over 600 members, for our opinion. If they had, they would know that we SUPPORT the development of the SugarHouse Casino at its current site on North Delaware Avenue.

The former Jack Frost Refinery site is a blighted, unsightly lot that has been vacant for 20 YEARS. SugarHouse Casino will invest \$650 MILLION in the development of the site into an exciting waterfront development, with an outdoor promenade where people can enjoy the river. Our community wants and needs the jobs and the vendor opportunities that this development will bring to our city and community.

For almost a year, the board members of FACT have been engaged in conversations with the developer to create a Community Benefits Agreement (CBA). We are in the home stretch and hope to sign the CBA in the next few weeks.

We understand that there may be a meeting in the coming weeks to discuss re-siting SugarHouse. If, as some politicians argued, re-siting is about the community, then we hope and expect to be invited to any meeting so that we can make it clear to one and all that there is widespread support for SugarHouse in Fishtown.
